NZTROF CONSTITUTION

MEMBERS COUNCIL

Bernard Hickey is currently involved in interviewing for three directorships on the NZTR Board. The MC Constitution is being amended with the intention of recognising all industry organisations (including NZTROF) to have voting rights and wider powers to ensure transparency and accountability.

The Committee expressed its thanks to national President Bernard Hickey for his proactive work on the Members Council and within the industry during recent challenging times.

OWNERS' BULLETIN

The September issue had been very well-received with a lot of positive feedback. Neil Miller was thanked for his work on another excellent issue of the Owners' Bulletin.

GENERAL BUSINESS CONCERNS REGARDING TAB

Michael Dowd voiced his disappointment at the actions of the TAB, in particular their treatment of Des Coppins. Dissatisfaction about the loss of Radio Trackside, including Des Coppins' Sunday programme, as well as broadcasting of races and other informative interviews/commentary, was expressed. The current lack of information for racing enthusiasts and punters, including in the NZ Herald, was lamented.

It was AGREED to write a Remit about the Auckland Owners Association's concerns regarding the TAB, quality of content and the treatment of Des Coppins, to be forwarded for discussion at the NZTROF AGM 2020.

ACTION: Committee members to give their comments to President Mike Gething to formulate a Remit to put forward to the Federation AGM 2020.
