MINUTES OF THE ANNUAL GENERAL MEETING OF THE AUCKLAND THOROUGHBRED RACEHORSE OWNERS' ASSOCIATION INC, HELD AT THE ELLERSLIE RACECOURSE, LADY FISHER ROOM, 80 ASCOT AVENUE, GREENLANE, ON SUNDAY, 17 NOVEMBER 2024, AT 2.30 PM.

GUEST SPEAKER

The meeting was preceded by a presentation from Paul Wilcox, CEO of the Auckland Racing Club, with an update on current progress at Ellerslie.

The recent problems with the track surface had been resolved, some of which had been caused by the wrong grass being used. Australian experts had been called in to make recommendations for remediation.

ARC was in a good financial position which would mean a further increase in racing stakes, not just at the top end.

There were ongoing discussions with potential development partners for replacing the stand in a sustainable way.

Racing at Pukekohe had been a positive part of change.

Avondale was working toward a Memorandum of Understanding with NZTR.

Paul was thanked for the update.

PRESIDENT'S

REPORT

The President presented a report on activities for the year.

The main interest items were:

- A strategic proposal had been put to Members Council and NZTR to become voting members of NZTR. This would mean Owners, Trainers, Breeders and Jockeys would get a voice alongside Racing Clubs who presently are the only ones to have a vote. The NZTR Board supports the proposal and the NZTR Constitution is currently being reviewed to allow for this. When completed, it will be presented at a special NZTR Board Meeting in 2025. Ultimately, this will be a bonus for stakeholders to have more visibility and voice.
- The Committee supported the proposed new jockey fees as presented by NZTR, recognising the risks and sacrifices jockeys make.
- The Committee supported the retention and encouragement of jumps racing with New Zealand.
- The Committee supported the IT capacity of NZTR to track and identify trends and issues regarding horse welfare, injury and ceasing of racing of a particular horse.
- Entain had brought innovation and taken wagering to a new level. Trackside was back on free-to-air television and there were higher stakes.

The President thanked Committee members for their work during the year.

Neil Miller's dedication to the production of *The Bulletin* was again acknowledged with sincere thanks, as was Raewyn McKenzie's work as Committee Secretary/Treasurer for many years.

Thanks were extended to NZTROF President Bernard Hickey for working tirelessly for members in putting forward views of owners, members and the executive.

Auckland Thoroughbred Racehorse Owners Association PRESIDENT'S REPORT 2025

It is my pleasure, as President of the Auckland Owners Association, to report on the past year. It's been great having Ellerslie back in full swing – all the main days were as big as ever and Champions Day on 8th March was a huge success with the inaugural NZB Kiwi. There were also midweek meetings, Sunday meetings and a number of trials held at Ellerslie, with a more relaxed vibe on course and the opportunity to get up close to the trainers, horses and general action.

Race days at Pukekohe are always well supported and a lot of fun with a big turnout for the Counties Cup on 22nd November. Ruakaka, our other northern venue, puts on a really good show in its "surf meets turf" setting.

There have been a number of abandonments and there was a period of time when it was hard to get horses to trial in the north. Nevertheless, there have been plenty of Auckland members with winning horses over the year. The familiar yellow/black checked silks of Brendan & Jo Lindsay went past the post first on many occasions. Winners for Haunui Bloodstock, Te Akau and Go Racing syndicates which a number of our members are part of. La Crique has had a string of strong seconds for the Cassins – she's as honest as and will hopefully get a Group 1 win this coming year.

Our Association supported a fundraising event for Riding for the Disabled Association (RDA) through Auckland member Loraine Grant. Held on 30th March 2025 at Totara Park, we donated \$500 via Committee member Craig Leishman's company which went towards sponsoring a sculpture in the Park. Committee members Mike Gething and Pat Woollaston attended on the day and had a fabulous time.

Your Committee organised a successful outing for members in July. We had a hosted visit at the Cambridge Stud Heritage Centre in July - racing nostalgia and magnificence. Afterwards, some had lunch in town and a group headed to Cambridge Synthetic for an afternoon of racing. It was a great opportunity to connect with several members of the Waikato Owners Association. Thank you to Committee member Virginia Healey for organising this – there was a write-up in the Autumn 2025 *Owners Bulletin*. It hasn't been possible to organise and host a social event for our members this year, but we're aiming to do so in 2026.

To align with the requirements of the new Incorporated Societies Act 2022, a sub-committee worked on reviewing and revising our Constitution. As per the Agenda, we will vote to ratify the draft at our 2025 AGM as well as vote on re-registration for our Association. It's a longer document than the previous one, but it covers all the necessary elements.

With my Auckland Association Delegate hat on, I attended an in-person Federation workshop on 30th March, together with VP and Reserve Delegate Lex. This looked at the NZTROF Constitution as well as its future direction. We also attended various Executive meetings throughout the year, on Zoom, to discuss relevant ownership issues. I worked separately and in detail with NZTROF President Bernard Hickey and Executive Officer Denise Mayhew to finalise the Federation's revised Constitution which will be voted on at the AGM on 7th December. This work gave me confidence that ours is appropriate and

aligned. I'd encourage you to attend the NZTROF AGM if you can (to be held at Jetpark, Auckland Airport).

I attended the NZTR AGM on 25th November on behalf of NZTROF. I attended online. The revised NZTR Constitution was approved – this means that Recognised Industry Organisations (Owners, Jockeys, Breeders, Trainers) are now included as members of NZTR – along with racing clubs – in line with the Racing Act 2020. NZTROF President Bernard Hickey attended the meeting – he has driven this work, through Members Council, and it's a great result, giving us a stronger voice and higher visibility in the industry.

NZTR CEO Matt Ballesty introduced the new Management Team and presented the organisation's Strategic Plan which is future and action-focussed to attain excellence in many areas that have been lacking. The industry has been seriously challenged for a long time, so let's hope they can achieve all the goals that have been set, one of which is to enhance ownership. If so, there's a much brighter future ahead.

NZTROF President Bernard Hickey is stepping down at the AGM and the Auckland Committee has nominated me for the role. If elected (there is another nomination from Waikato) I will work to keep them on track!

Life member, and longtime *Owners Bulletin* Editor, Neil Miller, has been unwell over the latter part of the year. With his guidance, I stepped in as Acting Editor for the Spring 2025 edition and it went to print end November (and includes reference to NZTR's new strategy). That was to be Neil's final issue – we thank you for your unwavering commitment to sharing racing stories, information and updates through this, the only regular racing publication that remains. A great job done.

Committee members Frances Crimmins and her son Elliot Wilton stepped off the Committee during the year. Frances has been involved for many years and Elliot more recently and we thank them for their time and energy. Frances is a wonderful horsewoman who has bred and raced some great horses through the years, Sir Slick a firm favourite, and we're sorry to lose her. She always brought passion, wisdom, perspective and a lovely smile to our meetings – along with great cheese and crackers! We'll miss you both.

The racing industry employs 24,000 people, making it one of the top employers in NZ, and it brings \$1.3 billion to the economy. The importance of the industry we love cannot be underestimated and we hope that, under the new management structure and strategic plan, NZTR can take it forward in a truly positive way.

Auckland members race their horses in the Waikato, the CD and the South, as well as in the North. Some have even got to race their horses over in Australia. Wherever you got your thrill, I congratulate all Auckland members who had winners during the period.
